Expediting Croatia's EU Accession Critical to Economic Prosperity/Development of SouthEast Europe

The American Chamber of Commerce in Croatia (AmCham Croatia) commends Croatia's efforts and commitment in its objective of being a full participating member of the Trans-Atlantic security and economic community, specifically the demanding and complex processes of membership in the North Atlantic Treaty Organization (NATO) and accession to the EU. It is commendable that the overall EU negotiations are progressing positively and relatively quickly. As a business organization, representing over 160 companies in Croatia and committed to the service of its members, AmCham Croatia is also very interested in the Croatia-EU & Croatia-NATO negotiations, especially regarding all the aspects involving the economy and the daily operational effects to the economy and businesses.

AmCham Croatia's support of Croatia's aspirations to become full members of the EU and NATO stems from the fundamental principle of promoting free-market principles, which historically has been the key to the economic and security stabilization of countries.
