# Conference "Croatian Presidency of the Council of the EU - Competitiveness and Growth"

In January 2020, Croatia takes over the Presidency of the Council of the European Union having an important role of representing common interests of the Member States. Croatia will work on achieving set goals as well as suggesting and defining direction of European policies for the upcoming period.
