## **Useful information:**

#### Cost

Fee for being part of the delegation is HRK 2,400 (plus VAT) per person. Members pay the cost of accommodation, airplane ticket and transport to and from the airport.

#### **Application**

The number of delegation members is limited to 22, and participation is only intended for AmCham Members. Places will be allocated on a first-come, first-served basis. Two representatives per member company can participate, additional persons can be added to the waiting list. #### **Flight**

- Notes:
  - o If you use the code on the website/in the app, you enter it into the box reserved in the search bar. When purchasing online you can ask for a R1 invoice, but not for a pro-forma invoice. Card-payment only.
  - o To use the discount in the Contact center or sales offices, the person has to immediately stress the possession of the discount and name the code. It is possible to get a pro-forma invoice and make a payment accordingly.

## Hotel

After purchasing the ticket, depending on your need for stay, we suggest booking a hotel.

We recommend that delegation members stay at the <u>Renaissance Brussels Hotel</u> because of the special conditions for **bookings until 15 June 2022** arranged by AmCham. The price of bed and breakfast is  $\\epsilon 189.00 + \\epsilon 4.24$  for city tax. Bookings can be made for:

- Thursday, 30 June (day of the program)
- Wednesday, 29 June and Thursday, 30 June

You will receive the booking link after you apply.

#### **Personal information**

To visit the institutions, you have to provide the delegation member's personal information, including first and last name, company, position, ID type (ID card or passport) and the number of the ID document. If the European Parliament requires additional information (such as the

Croatian PIN (OIB), date of birth, travel document expiration date...), you will be notified on time.

AmCham will collect the listed information and share them with AmCham EU, the Office of the Member of the European Parliament Tonino Picula, Permanent Representation of Croatia to the EU and the European Parliament. Your information will not be used for other purposes.

In order to ease the communication and information sharing, AmCham will also create a WhatsApp group a couple of days before departure. The group will be deleted after the trip.

#### **Dress code**

Dress code for the meetings and visit to the European Parliament is **business attire**. All locations are at a walking distance of 5 to 15 minutes so adequate footwear is recommended. To visit the institutions it is necessary to have **an ID document (ID card or passport)**.

#### **Healthcare insurance**

It is recommended for delegation members to acquire the European Health Insurance Card if they do not own it already.
